SharinPix Privacy Policy

This privacy policy has been compiled to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as described in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context.

Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

What personal information do we collect from the people that use our Mobile App?

When using SharinPix mobile App, you may be asked to upload picture to our services in order to provide those to your company process as implemented on top of SharinPix. We may store those pictures and associated metadata on our servers according to the wanted implementation by your company.

When do we collect information through our Mobile App?

We collect information from you when you upload images to SharinPix (choose picture from your roll or take new pictures from the SharinPix app).

How do we use your information collected from our Mobile App?

We may use the information we collect from you to deliver to your company process within the SharinPix app implementation.

SharinPix mobile App Usage

You may have to check with your company the usage done with those images

data. We deliver those information to the company who is asking you for an image upload. SharinPix don't use those information on our side for any purpose.

Third-party disclosure

We do not sell, trade, or otherwise transfer to outside parties your Personally Identifiable Information.

Fair Information Practices

The Fair Information Practices Principles form the backbone of privacy law in the United States and the concepts they include have played a significant role in the development of data protection laws around the globe. Understanding the Fair Information Practice Principles and how they should be implemented is critical to comply with the various privacy laws that protect personal information.

In order to be in line with Fair Information Practices we will take the following responsive action, should a data breach occur:

We will notify you via email

• Within 7 business days

We also agree to the Individual Redress Principle which requires that individuals have the right to legally pursue enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or government agencies to investigate and/or prosecute non-compliance by data processors.

CAN SPAM Act

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

SharinPix mobile App doesn't collect any email information. Those information are only stored from your AppExchange inquiry, your usage from a third party application such as Salesforce or when you provide us

your coordinates during a commercial interaction (Events, Contact web form, email inquiry, ...)

We collect your email address in order to:

- Process orders and to send information and updates pertaining to orders.
- Send you additional information related to your product and/or service

To be in accordance with CANSPAM, we agree to the following:

- Not use false or misleading subjects or email addresses.
- Identify the message as an advertisement in some reasonable way.
- Include the physical address of our business or site headquarters.
- Monitor third-party email marketing services for compliance, if one is used.
 - Honor opt-out/unsubscribe requests quickly.
 - Allow users to unsubscribe by using the link at the bottom of each email.
